- EPTL 1: Organization is not charitable

- EPTL 3: Organization is a government agency or is controlled by a government agency
- EPTL 4: Organization reports annually to either the U.S. Congress or the NY State Legislature
- EPTL 5: Organization is incorporated under the religious corporations law, etc.
- EPTL 6: Organization is an educational institution, museum or library...
- EPTL 7: Organization is a hospital
- EPTL 8: Organization is a membership corporation...
- EPTL 9: Organization is a volunteer fire fighters or ambulance service
- EPTL 10: Organization is a historical society...
- EPTL 11: Organization is a cemetery corporation subject to the provisions of Article 15 of the NY State Not-For-Profit Corporation Law

- Art. 7-A, 3: NYS contributions under \$25,000 and from single govt. agency
- Art. 7-A, 4: Contributions under \$25,000; receives from a federated fund; no professional fund raiser
- Art. 7-A, 5: Organization is incorporated under the religious corporations law, etc.
- Art. 7-A, 6: Organization is an educational institution that confines its solicitation...
- Art. 7-A, 7: Organization is an educational institution or museum, etc.
- Art. 7-A, 8: Organization is a library, etc.
- Art. 7-A, 9: Organization is a membership organization...
- Art. 7-A, 10: Organization is a law enforcement support organization...
- Art. 7-A, 11: Organization is a historical society...
- Art. 7-A, 12: Organization is the NY State PTA, etc.
